The Dartmouth Yacht Club collects personal information such as name, address, contact information, boat and insurance information and other information as may be necessary for membership records and for the purpose of billing and internal communications. The information is retained at the Dartmouth Yacht Club office and is only accessible by Management or the individual club member, upon request.

Our privacy policy and reasons we collect, use and disclose your information is so that the DYC can: a) better understand the requirements of our members, b) provide information about services and programs, c) inform members of events, information, policies and procedures of the DYC, d) billing and collection of dues and fees, e) publication of the DYC annual Member's Directory, f) comply with the law.

**GENERAL RELEASE - CREW AND SOCIAL MEMBERS**

I, \_\_\_\_\_, if approved, as a member of the Dartmouth Yacht Club (DYC), hereby acknowledge that DYC is a private members' club that provides facilities and limited services associated with the use, docking, mooring and storage of recreational boats and/ or yachts (all herein referred to as boats), and that I will use those facilities *at my own risk*.

I acknowledge that DYC is under no obligation to inspect any boat at the DYC; nor is DYC obliged to inspect any associated boat equipment for seaworthiness or fitness for purpose. Boat owners/operators are responsible for their own boats.

I acknowledge that I am solely responsible for any guests that I invite to DYC and, without limiting the generality of the foregoing, I acknowledge that I am solely responsible for the safety, well-being and behaviour of my guests.

I hereby agree to indemnify DYC with respect to any legal proceeding arising from my actions and/or omissions or those of any of my guests. Without limiting the generality of the foregoing, I agree to indemnify DYC with respect to all legal claims or proceedings arising from or based on my negligent actions or omissions and those of my guests or crew.

I acknowledge that I and my guests have the use of DYC equipment and property *at our own risk*, and without limiting the generality of the foregoing, that I and my guests use the DYC facilities, marina docks, piers, wharfs, and moorings *at our own risk*.

I acknowledge that DYC has made reasonable effort to ensure that its facilities are properly designed, constructed and maintained for the intended purpose, and I agree to report any defects which I observe to DYC Management.

I acknowledge that DYC is not liable for any personal injury or death to me or my guests, caused by or resulting from the natural elements, disasters, insurrections, civil disorders, war, terrorism, vandalism, acts of third parties, or other misfortunes and/or acts of God.

I confirm that I shall indemnify DYC, its officers, management, appointees, staff/employees and volunteers when assisting with a Club event, from all legal claims, actions and proceedings arising from or based on the death or personal injury of any person, or damage to any boat or property, as a result of any act or omission by me, my crew or guests.

I have reviewed the forgoing and understand the nature of this general release and I am signing it voluntarily. I agree that this release shall be binding upon me, my heirs, successors and assigns.
