#### **GENERAL RELEASE - MEMBERS**

(To be signed in duplicate)
(PLEASE READ CAREFULLY BEFORE SIGNING)

I,, as a member of the Dartmouth Yacht Club (DYC), hereby
acknowledge that DYC is a private members' club that provides facilities and limited services associated with the
use, docking, mooring and storage of recreational boats and/ or yachts (all herein referred to as boats), and that
I will use those facilities at my own risk.

I understand and agree that I will be solely responsible to ensure that:

- Any boat I own, operate or maintain at DYC, and all of its associated equipment is fit for the intended purpose and use and that the boat is seaworthy;
- Any cradle or jack/boat stands I supply are fit for their intended purpose. I realize that DYC will not inspect any equipment I supply or use for the boat and that it is my responsibility to insure all such equipment is suitable and fit for its intended purpose; and.
- When I supply and/or use boat/jack stands it is my responsibility to inspect them regularly to ensure the stands are properly set, tensioned and chained. I acknowledge that no lines (e.g. boat cover ties or other devices) are to be connected or tied to the stands.

I acknowledge that DYC is under no obligation to inspect any boat I, or other members, own, operate or maintain, nor is DYC obliged to inspect any associated boat equipment for seaworthiness or fitness for purpose.

I understand that if my boat, and/or associated equipment, is damaged as a result of my equipment failure or use, that DYC is not liable, and I shall make no claim for personal injury or damage against DYC as a result of, or arising from, damage to my boat or its equipment. I acknowledge that DYC is not liable for any damage to my boat and/or associated equipment by other members of DYC, or boats operated, owned or maintained by other DYC members and/ or their guests.

I acknowledge that I am solely responsible for any guests that I invite to DYC and, without limiting the generality of the forgoing, I acknowledge that I am solely responsible for the safety, well being and behaviour of my guests.

#### **INSURANCE:**

I agree to provide proof of All Risk Public Liability Insurance with respect to my boat and associated equipment in the minimum amount **established each year at the AGM**, (\$2,000,000 in 2023) to DYC **annually**. I understand that if proof of that insurance is not provided, I will not be permitted to launch, lift, keep or maintain my boat at DYC.

### MEMBER'S LIABILITY TO THE DARTMOUTH YACHT CLUB

I hereby agree to indemnify DYC with respect to any legal proceeding arising from my actions and/or omissions or those of any of my guests or crew. Without limiting the generality of the forgoing, I agree to indemnify DYC with respect to all legal claims or proceedings arising from or based on my negligent actions or omissions and those of my guests or crew.

#### **DOCKS**

I acknowledge that I and my guests have the use of DYC equipment and property *at our own risk*, and without limiting the generality of the foregoing, that I and my guests use the DYC marina docks, piers, wharfs, and moorings *at our own risk*.

I acknowledge that DYC has made reasonable effort to ensure that its facilities are properly designed, constructed and maintained for the intended purpose. I understand that dock maintenance is a DYC responsibility, and I agree to report any defects which I observe.

#### MAST CRANE

I acknowledge that the mast crane is only to be used for stepping/installing or unstepping/ removing masts. I understand that the mast crane is **NOT** to be used for lifting or removing engines or other equipment from my boat and must **NOT** be used to lift a person.

I further acknowledge that before using the mast crane I shall consult with DYC staff with respect to its proper usage and follow all safety procedures stipulated for its use, including wearing a construction grade 'hard hat' or helmet.

#### HAZARDOUS SUBSTANCES

I acknowledge that I am liable for any spillage of hazardous substances, including, but not limited to, fuel, propane or airborne pollutants, that I, my guests or crew cause, and that DYC does not inspect my boat or equipment with respect to the transport, transfer, fueling and/or storage of any hazardous substances.

#### SHORE/YARD ELECTRICAL POWER

I acknowledge that DYC is not liable or responsible to ensure that members' boats are properly connected to shore/yard power. I acknowledge that DYC has advised members that only certified electrical cords and connectors are to be used to connect boats to shore and/or yard power.

#### MARINA & MOORING

I acknowledge that it is my responsibility to ensure that my boat is properly secured to the dock in my assigned slip with adequate dock lines and fenders. Further, it is not DYC's responsibility to inspect my, or any other boat's, mooring or dock lines, and any damage arising from improperly secured boats is not a DYC responsibility. I acknowledge that it is my responsibility to ensure my boat is properly secured to the assigned mooring or dock by adequate mooring lines sufficient for my boat's size, weight, type and any weather or water conditions that might affect the boat. I acknowledge that DYC does not inspect my, nor other members', boats' mooring lines nor is it DYC's responsibility to do so.

### CRADLES AND OTHER STORAGE EQUIPMENT

I am aware of the manner in which boats are lifted and moved by the Marine Travelift and the Con-O-Lift cradle mover to their storage place. I realize that my boat's cradle will be moved by BobCat forklift, and it must be built to withstand such movement - with or without the boat on it. DYC is not responsible for damage which is the result of my boat, cradle or associated equipment not being fit for, or caused by, movement with due care and diligence. I acknowledge that it is my responsibility to ensure that my boat's cradle is fit for the intended purpose, and DYC does not inspect boats' cradles but has the right to refuse to place my boat on a cradle if the cradle is deemed to be inadequate for the boat.

#### **GENERAL**

I acknowledge that DYC is not liable for any personal injury or death to me or my guests, or damage to my boat or associated equipment, caused by or resulting from the natural elements, disasters, insurrections, civil disorders, war, terrorism, vandalism, or other misfortunes and/or acts of God.

I confirm that I shall indemnify DYC, its officers, management, appointees, staff/employees and volunteers when assisting with a Club event, from all legal claims, actions and proceedings arising from or based on the death or personal injury of any person, or damage to any boat or property, as a result of any act or omission by me, my crew or guests.

I have reviewed the forgoing and understand the nature of this general release. I agree that this release shall be binding upon me, my heirs, successors and assigns.
