[NP] b) Sail NS PHRF handicaps can be obtained through the Sail NS website at https://www.sailnovascotiaydb.ca/yacht/add c) Fleet splits will be made at the discretion of the Organizing Authority and posted no later than the end of the Competitors' Meeting. [NP] d) The RC reserves the right to adjust splits as necessary depending on number of boats and PHRF spreads. The fleet split intentions are as follows. > Spin classes. (A&B) > White sail classes (C&D) > One design classes. e) PHRF splits will be determined after registration, a minimum of four boats must be registered to comprise a class for any PHRF splits. |

| 10. Penalty System | a) RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty, except when the incident occurs in the zone where the penalty is a Two-Turns Penalty. |
